Water connection fees are the sum of the Water Plant Investment Fund (PIF), the Water Resource Fee, and the Tap Fee for parts and labor. Larger meter sizes will be computed upon customer request for connection. Additional equipment such as backflow preventers may be required, at customer cost, for connection to the water system as set forth in the regulations.

Larger sizes will be computed upon customer request for connection. 3/4" water meter requires a 4" sewer tap and a 1" to 3" water meter requires a 6" sewer tap. Larger than 3" water meter may require a larger sewer tap size dependent upon use. Additional equipment such as grease interceptors may be required, at customer cost, for connection to the wastewater system.
